Florida Exotic Pest Plant Council's 2001 List of Invasive Species

DEFINITIONS: *Exotic*—a species introduced to Florida, purposefully or accidentally, from a natural range outside of Florida. *Native*—a species whose natural range included Florida at the time of European contact (1500 AD). *Naturalized exotic*—an exotic that sustains itself outside cultivation (it has not "become" native). *Invasive exotic*—an exotic that not only has naturalized but is expanding on its own in Florida plant communities.

Abbreviations used:

for "Gov. list": P = Prohibited by Fla. Dept. of Environmental Protection, N = Noxious weed listed by Fla. Dept. of Agriculture & Consumer Services, U = Noxious weed listed by U.S. Department of Agriculture. for "Reg. Dis.": N = north, C = central, S = south, referring to each species' current distribution in general regions of Florida (not its potential range in the state). See map.



Category I - Invasive exotics that are altering native plant communities by displacing native species, changing community structures or ecological functions, or hybridizing with natives. *This definition does not rely on the economic severity or geographic range of the problem, but on the documented ecological damage caused.*

First Quarter Board of Directors meeting to order on 3 April 01 at 12:20.

Officers and Directors present included Ken Langeland, Dan Thayer, Amy Ferriter, Christine Sutter, Brian Nelson, Alison Fox, Hillary Cherry, Phil Waller & Jackie Smith. Others attending included Chris Lockhart, Randall Stocker, Doria Gordon, Bill Snyder, Cindy Campbell, Barry Argo, Brian Yahn, Phillip Myers and Kathy Burks.

A motion was made and approved to accept the minutes of the 4th Quarter Board of Directors meeting at the Panther National Wildlife Refuge in Naples, Florida on 12 December 00 (H Cherry/A. Fox).

Correspondence

As of 12 December 01 there has been no correspondence.

Treasurer's Report

Dan Thayer noted that as of 2 April 01, the Council had \$48, 364.92

Dan Thayer also noted that he would be resigning as treasurer as of September. He noted that Francois Laroche and Tony Pernas had offered to replace him.

There was discussion about Committee and Working Groups preparing budgets for each year. There was also discussion about how and where they can spend money. Ken Langeland request that all committees and working groups submit budgets to him by 15 April 01.

A motion was made and approved to accept the Treasurer's Report (H. Cherry/P. Waller).

Editor's report

Amy Ferriter passed around a list of places that receive extra *Wildland Weeds* Magazines. She noted that if you would like to receive extra magazines to please contact her and she would get them to you. Amy noted that in the fall issue, Richard Gaskalla from DACS Division of Plant Industry would be submitting an article about the Tropical Soda Apple Task Force. She noted that it would be an industry issue.

A motion was made and approved to accept the Editor's report (A. Fox/D. Thayer).

New business

FLEPPC collaboration with IFAS Invasive Plant Assessment

The IFAS Invasive Plant Committee has been working on a protocol to determine if exotic plants are invasive or not. They have gone through the first 20 species on our plant list. The main thing that they have learned is that the process is big & view it as one more thing to do. The IFAS folks also noted that there is just not enough money. Ken Langeland asked the Plant List Committee to form an association with the IFAS group for

facilitate a better working relationship. There were some questions about someone possibly using the IFAS list to advertise plants for the industry. Ken Langeland said that a better working relationship with the IFAS group should help prevent that. He also noted that this IFAS assessment would not effect our list or change how plants are listed on it.

Committee reports

By Laws – No report at this time.

Legislative committee - Phil Waller reported that he is having some trouble finding information on the state level. Most of his contacts are at the federal level. He did note that most of the concern at the state level is loss of important positions within state government. There was discussion about the 2001 State of Florida Legislative session not looking good for the environment. He noted that he was hoping that Steve Bell, PJ Myers and Randall Stocker would help his committee on the State level. Randall Stocker noted that FL EPPC should send a letter to the Florida Department of Agriculture and Consumer Services concerning the importance of Nancy Coils position with the Division of Plant Industry.

Phil then noted that Invasive Plant Awareness Week in Washington, DC had slipped by the Council again. He noted that most of those attending were from out west. There was a group from FL Department of Environmental Protection Bureau of Invasive Plant Management. Ken Langeland requested that Phil keep the Council up on this event for next year so that someone could attend from the FL EPPC.

Randall Stocker discussed the National Invasive Species Advisory Committee. He stated that he has been looking into what input the EPPC's have and stated that they need to have representation on this committee. He noted that all the positions on the committee would be replaced in October 2001. He is looking for a list of people to be nominated. The discussion led to making sure that Randall Stocker keep his position on the committee. It was also noted that Faith Campbell was also on the committee. Ken Langeland noted that we need to be more proactive in this process and Randall will be able to keep us in the loop. Ken Langeland requested that Randall draft some letters to the committee to promote the people we believe are best suited for representing us at the level.

The Department of the Interior looks like it may receive more funding for exotic plant control. The Dashell Bill (Senate Bill 120) provides small scale funding for weed control but the money goes mostly to the western US. On the upside there are also some monies going towards Florida and the Southeast

Local Arrangements – JB Miller handed out a list of the Council's cost for the September Symposium in St. Augustine. The meeting will cost approximately as much as the meeting in the Keys last year. We will be having a catered social at the Government House across the street from the hotel.

After a long discussion about the registration fee for the meeting, a motion was made and approved (H. Cherry/D. Thayer) to charge \$65 for pre-registration and \$75 for registration at the door with the social costing \$20 extra. There will be a \$35 one-day registration and student registration will be \$45. The Gypsy Cab Company was chosen to cater the social and it appears the menu is exquisite.

There was then some discussion about the 2002 meeting, which will be somewhere on the West Coast of Florida. There was discussion about combining the SE EPPC and Florida EPPC meetings. Randall Stocker stated that he would coordinate the

meeting and would like to address some of the international issues that USDA is working with. Although it will change the nature of the meeting it will bring in new ideas and people. The date will be sometime during September 2002.

Program committee – Kathy Burks discussed the Keynote speaker. Several people were suggested and Kathy indicated she would look into each one. Kathy also noted that submission deadline for papers would be 20 June. The program will be "Weeds in La Florida, 2001" Marking 500 years of first contacts with alien species and scouting the future of this odyssey.

Education Committee & Membership/Publicity Committee – Hillary Cherry introduced everyone to the new display. She showed how the display was interchangeable so anyone can use it anywhere. Hillary Cherry and Andi Van Loan are going to produce a FL EPPC brochure. Anyone with ideas should contact them.

Nominations – Tony Pernas put forth a list of nominations for new Board Members and new Chair-elect. After discussion, Ken Langeland will ask Tony to finalize the list by the next board meeting.

Merchandise – Bill Snyder bought 100 T-shirts, which were sold at the Great Air Potato Roundup in Gainesville. If you want to purchase some or would like to sell them at a meeting or event, call Bill and he will get them to you. There was some discussion about what to prepare for the upcoming meeting. Bill was given ideas and will bring the board a list of items to the next board meeting.

Plant Industry Liaison – Doria Gordon noted that JB Miller would be replacing Roger Hammer on the committee. He attended the meeting on 10 January 01. It was noted that the DACS liaison might be changing. Doria noted that this could change the way the group works together. Ken Langeland requested that Doria draft a letter for his signature requesting that the DACS liaison not change. The next meeting will be 10 April 01.

Ken Langeland noted that the "plant locators" are listing many plants that have been agreed upon through this EPPC/FNGA group not to be sold. Doria stated that FNGA is trying to straighten this out and she will discuss this problem at the upcoming meeting.

Doria noted that the FNGA wants an article on what to do with trash nursery material. She noted that this issue is high on the next agenda along with clarifying the footnotes on our plant list especially where sterile cultivars are concerned.

Plant list – The 2001 list is out. Kathy Burks noted that the EPPC Occurrence Database has also been updated. She noted that there are 4,914 entries. Sixty-two of the 68 counties in the state are represented (Baker, Bradford, Gilchrist, Lafayette, Taylor & Union are not represented). One hundred percent of the Category I plants are listed on the database but only 54 of the 56 Category II plants are listed (*Cordia dichotoma* & *Limnophila sessiliflora* are not). Please send any sightings of these or any listed plants to Kathy.

Publications – No Report at this time.

Research – No report at this time.

Training – The test is completed. The manual has just a few changes that need to be made to cover all the test questions. Once everything is complete, DACS will announce where and when the tests can be taken.

Vendor – Phil Waller noted that Brad Cochran has agreed to take over the vendor committee and assured us he will do a bang-up job.




